The Wahoo Board of Education met in regular session on Monday, April 20, 2020 at 6:00 p.m. in the High School Media Center located at 2201 N. Locust, Wahoo, Nebraska. Publicized notice was given by publication in the <u>Wahoo Newspaper</u> on Wednesday, April 15th and posted on the school's website, facebook and doors.

The meeting was held as a virtual meeting online in order to comply with the CDC's recommendation. It was moved by Hancock, seconded by Eddie to accept the resignation of High School Principal Jarred Royal, effective at the conclusion of the 2019-2020 school year. On roll call vote all members present voted yes. Motion carried. The board wishes Mr. Royal the best of luck with his new position.

A motion was made by Hancock, seconded by Grandgenett to approve the hiring of Vernon Golladay for the High School Principal, Alicia Holtorf for 2nd grade, and Staci Obermbt as the .50 FTE Library/Media teacher for the 2020-2021 school year. On roll call vote all members present voted yes. Motion carried.
